- 1. To elect a Chairman for the forthcoming year and receive the Chairman's declaration of acceptance of office Cllr Betts was nominated by Cllr S Mellor and seconded by Cllr N Wilkins and was duly elected as Chairman. The form will be signed and returned to the clerk.
- 2. To elect a Vice-chair and receive the Vice-chairman's declaration of acceptance of office Cllr S Mellor was nominated by Cllr Hadley and Cllr Wilkins and was duly elected as Vice-Chair. The form will be returned to the clerk in due course.
- 3. Open Forum An opportunity for any parishioner to speak on parish matters and to hear reports from District and County Councillors, if applicable A member of the public asked about a specific fir tree near their property on the B1077 which is potentially problematic for several reasons. The tree is particularly tall and this could be a safety issue in high winds but also the roots may cause damage to nearby properties and the B1077. It is also blocking light and attracts several pigeons. The Chairman confirmed that he had mentioned this tree when having general discussions with NCC Highways and will ask for their views on whether it warrants further inspection and remedial action.   County Councillor Ed Connolly confirmed that most employees of the County Council are currently working from home. Councillor Connolly said that he had been very impressed with the response from the parish, to the Covid-19 situation. Arrangements were in place very quickly to ensure that vulnerable residents received the help they needed. To report matters arising not on the agenda and hear the Chairman's report The Chairman reported that Kerry Foods donated an amount of ready meals for residents that may need them and they are about to make a further donation. The pupils attending the village primary school designed some greeting cards, which were delivered to 100 households in the village, who were thought to need a bit of joy. up to become a "Parish Friend' of the mobile library service Parishes will be recorded alongside their book issues and at the end of the year the parish with the highest amount of book issues will win the 'Parish Friends Cup', which they can keep for most of the following year. The library service hopes that this will foster some friendly competition and help encourage parishioners to visit the Mobile Library and see what they have to offer. The parishioners need only to visit the Mobile Library and borrow/return books to us to help their parish win the Cup. It is hoped this will begin in January 2021.

Active Norfolk have made some exercise packs available, to help elderly or less able-bodied residents take some gentle exercise without leaving the home. The Chairman has asked for twenty packs, so please get in touch if you would like to receive a set. The packs are small and lightweight, containing: a guided home exercise booklet; a resistance band (yellow, lightest resistance); a Sitting Room Circuits DVD which contains a half hour guided walk through of gentle exercises that can be done at home and are suitable for those that currently do little or no exercise plus information leaflets with tips on reducing sedentary behaviour and information about a physical activity call-back service for individuals that want tailored 1:1 advice over the phone.

The Chairman gave a brief summary of a recent zoom meeting attended by both District Councillors and two representative residents to discuss the traffic and speeding issues in the village generally but particularly on the C136. The Chairman has written to local businesses, farmers and contractors explaining the concerns of residents and asking if their business would adopt a voluntary 20mph speed limit on the road. This has received some favourable responses. The Chairman will also be taking up the possibility of the installation of at least one road safety chicane on Long Street with Norfolk County Council Highways. With regard to future concerns surrounding the possibility of the new Attleborough Link Road encouraging people to use Great Ellingham as a cut through, a list of people who would need to be involved in this project has been collated and the Chairman is preparing a project plan. **(TB)**
